INSPECTOR GENERAL SENIOR LEVEL TRAINING COURSE

A Civil Air Patrol Inspector General Senior Level Training Course is scheduled for Thursday and Friday, 14-15 May 2015 at the Pennsylvania Wing Headquarters on Fort Indiantown Gap. Non-commuting students should plan to arrive on Wednesday, 13 May. Sign-in will be Thursday morning at 0730 at the class site. Class will start PROMPTLY at 0800 on Thursday, and will be held all day Thursday and will be released by 1700 on Friday.

Cost: There will be a \$25 charge associated with this course payable in cash at sign-in. A receipt will be provided. A light breakfast, snacks, refreshments, and lunch will be provided both days.

Billeting: The following is a list of hotels in the Fort Indiantown Gap area. All are about 2 miles from the PA Wing Headquarters, except the Comfort Suites, which is about 12 miles away. Most of them will give CAP a military rate of about \$60/night.

Directions: The post is accessed from exit 90 of I-81. Go west on Fisher Avenue for less than 2 miles. The PA Wing HQ is on the left just after you pass the huge Fort Indiantown Gap sign. There is no requirement to show ID to enter the post as far as the PA Wing HQ. The HQ building is #3-108.

Student Requirements: Space is limited. All applicants must be current members of Civil Air Patrol. Applications will be accepted in the following priority (members of NER will have priority):

1. Applicants assigned as Wing or Region Inspectors General or assistants.
2. Applicants assigned as Group, Wing or Region Commanders
3. Applicants assigned as Group, Wing or Region Vice-Commanders or Chiefs of Staff.
4. Applicants assigned as Legal Officers.
5. Other interested members with the approval of the CAP/IGT.

Uniform Requirements:

AF blue shirt with or without a tie or CAP aviator shirt with or without a tie or dark blue golf shirt worn in accordance with CAPM 39-1. Laptop computers are encouraged, but not required.

Application Procedures:

Prerequisites for this course are the IG Inspection Augmentee Course and the LMS IG Investigating Officer Course, found on the LMS (Learning Management System) on eServices, which must be completed in advance of attending this course.
